## 1. BASIC RIGHTS

CoS: Recovering fees when revoking a residence permit with retroactive effect is allowed in some cases

This case is about an Afghan whose asylum status is withdrawn with retroactive effect because he has visited his country of origin several times. Normally, in such situations, any additional fees [toeslagen] will not be recovered with retroactive effect, but as the status is withdrawn due to his own behaviour, the Council of State allows it in this case. ## 2. ADMISSIONS POLICY

CoS: if someone has a regular status, he/she can still apply for asylum

Until recently, someone with a regular status could not apply for asylum, as their safety was already guaranteed by the right of residence. The Council of State has recently decided that an asylum request from someone with a temporary regular status must be accepted for processing after all. According to the European Procedure Directive, an application for asylum must always be accepted for processing. See [here](#).

Court: partner's residence permit rightfully revoked, relationship ended despite living together

According to the court, a partner's residence permit may be revoked if the relationship has ended, even if the formal marriage still continues, the partners still live at the same address and share their meals. The man has confirmed several times to the IND that the relationship has broken down, that both partners have their own income, and that they no longer do anything else together. The woman did not want a divorce because that would not be accepted by the Indonesian community. See [here](#).

Court: IND must also grant entry visas to non-Dutch children of a mother to a Dutch child

The mother of this Dutch child got a visa to come to The Netherlands, so her child could grow in The Netherlands. Her other (non-Dutch) children did not get a visa. The court decided that the rights of the Dutch child, to grow up with her mother in The Netherlands, are impaired. See [here](#)

Court: journey in connection with family reunification of a refugee's sick 70-year-old mother who was left behind, allowed

This case is about the 70-year-old, sick mother, whose daughter, a Syrian refugee, has been admitted to The Netherlands. The mother cannot take care of herself and lived with her daughter until the daughter fled. The granddaughter who was left behind as informal carer was killed during a bombing. It is uncertain whether there is sufficient care available, having regard to the uncertain situation in Syria. The IND had rejected the application for a residence permit, because the mother had already survived in Syria without her daughter for two years. But the court finds that insufficient account has been taken of the unstable situation in Syria and the personal ties. See [here](#)

### 3. INSPECTION AND DETENTION

#### SvJ&V: detention of children

According to the secretary of state, efforts are made to make alien detention for families with children as humane as possible. The family is picked up in the morning before school starts, the vans are as neutral as possible and the family is not first taken to a police station but directly to the Closed Family Facility. To be able to act quickly, the family gets little time to say goodbye or pack their belongings, but their belongings will be forwarded.

The secretary of state undertakes to ensure that the Transport and Support Service will be well informed in advance of the situation of the family. See [here](#).
